A Resolution to Adopt the Magna Carta of the Rights and Responsibilities of the Undergraduate Students of the Ateneo De Davao University and to Endorse it to the Office Of Student Affairs

WHEREAS, the undergraduate students of Ateneo de Davao University, aligned with the Jesuit mission and the University's commitment to truth, peace, and justice, recognize the need for a document that ensures their comprehensive development within the academic community.

WHEREAS, the SAMAHAN Constitution, as the law of the land, embodies the will, ideals, and aspirations of its constituents;

WHEREAS, Article 2, Section 4, Paragraph 1 of the Constitution states that it shall defend and promote the rights and welfare of all Ateneo de Davao University undergraduates and individuals, regardless of gender, religion, academic status, race, or citizenship.

WHEREAS, the Magna Carta of the Rights and Responsibilities of the Undergraduate Students is a comprehensive document that outlines the fundamental rights, privileges, and responsibilities of students within the academic community

WHEREAS, the Magna Carta of the Rights and Responsibilities of the Undergraduate Students is essential for clearly defining student rights and responsibilities and facilitating the holistic development of the university's undergraduate students.

WHEREAS, adopting the Magna Carta of the Rights and Responsibilities of the Undergraduate Students reflects SAMAHAN's commitment to advocating for the equitable treatment and empowerment of all students, fostering a campus environment that is just, and inclusive.

WHEREFORE, BE IT RESOLVED, that the Student Assembly approves and adopts the Magna Carta of the Rights and Responsibilities of the Undergraduate Students as a

foundational document adhering to its commitment to defend, promote, and uphold the rights and responsibilities of the undergraduate students of the Ateneo de Davao University.

RESOLVED FURTHER, that the Magna Carta be forwarded to the Office of Student Affairs for approval and implementation.

RESOLVED FURTHER, that if any provision of this Magna Carta is declared invalid or unenforceable by a competent authority, the remaining provisions shall remain in full force and effect

RESOLVED FURTHER, that copies of this resolution and the Magna Carta of the Rights and Responsibilities of the Undergraduate Students be forwarded to the SAMAHAN Central Board and relevant university offices to ensure transparency and awareness.

RESOLVED FINALLY, this Resolution shall take effect immediately upon its publication in SAMAHAN's traditional or non-traditional media outlets.
