A RESOLUTION CONFIRMING THE APPOINTMENT OF JAN A.G. ADRIAN LARIEGO AS THE HEAD COMMISSIONER OF COMMISSION ON AUDIT

WHEREAS, according to Article V, Section 5.3 of the 2020 SAMAHAN Constitution, the Student Assembly shall “Serve as the Commission on Appointments which shall review, approve, and/or reject appointments made by the SAMAHAN Central Board, which shall only include Department Heads and Commissioners;”

WHEREAS, on June 24, 2024, the SAMAHAN Central Board President, Hon. Leen Juliet S. Lapatis, issued Memorandum No. SCB-Pres-05-060124, titled “Appointment of Commission on Audit and Commission on Students’ Rights and Welfare Head Commissioners for A.Y. 2024-2025,” which officially appointed Mr. Jan A.G. Adrian Lariego (hereafter referred to as the Appointee) as the Head Commissioner of the SAMAHAN Commission on Audit;

WHEREAS, according to Article V, Section 5.3.1 of the 2020 SAMAHAN Constitution, “The Student Assembly shall require the SAMAHAN Central Board to submit the Curriculum Vitae of the appointee, accompanied by a Letter of Endorsement;”

WHEREAS, according to Article VIII, Section 1.4 of the 2023 Student Assembly Code of Internal Procedures, “As part of the deliberation process, a Panel Interview with the new Department Directors and Head Commissioners must be conducted inside the Student Assembly;”

WHEREAS, on June 8, 2024, the Student Assembly received Mr. Jan A.G. Adrian Lariego’s Curriculum Vitae and Letter of Endorsement, and the Commission on Appointments subsequently conducted a panel interview for his prospective

appointment approval on July 9, 2024;

WHEREAS, on August 27, 2024, Mr. Jan A.G. Adrian Lariego was requested to attend an additional panel interview, following the determination by the Commission on Appointments that further supporting information was necessary to facilitate the approval of his appointment;

WHEREAS, it was identified after the callback panel interview that the appointee has the appropriate knowledge of the role and the experience working within the commission, equipping him to effectively fulfill his duties as the Department Director of the SAMAHAN Commission on Audit;

WHEREFORE, BE IT RESOLVED, the Commission on Appointments, chaired by the SAMAHAN Vice President and the Convener and Chairperson of the 4th Student Assembly, Hon. Sung Goon Acosta, after rigorous and careful deliberation, has determined that Mr. Jan A.G. Adrian Lariego demonstrates a clear understanding of the responsibilities associated with his appointed position as the Head Commissioner of the SAMAHAN Commission on Audit, as well as the objectives of the commission;

WHEREFORE, BE IT FURTHER RESOLVED, that the Commission on Appointments commends Mr. Jan A.G. Adrian Lariego for his qualifications and preparedness for the role, and encourages him to advance the goals and initiatives of the SAMAHAN Commission on Audit with dedication and effectiveness;

WHEREFORE, BE IT FINALLY RESOLVED, that the appointment of Mr. Jan A.G. Adrian Lariego as the Head Commissioner of the SAMAHAN Commission on Audit has been duly approved.
